## Meeting Highlights from 08/14/2019

Group reviewed meeting highlights from 08/14/2019. No changes were made to the highlights.

#### Access to Care for Uninsured

Dr. Nakatsuchi provided an overview of dental screening provided at the Northgate back to school event. At the Northgate event, 39 individuals were seen, 26 children and 13 adults. A majority (77%) screened (30 of 39) had unhealthy gums. A total of 85% screened, (33 of 39) reported not having a dentist. As a result of the event, Dr. Nakatsuchi led a conversation on access to care options in Orange County.

- 1. Where do uninsured/undocumented patients go for basic dental services?
  - Lestonnac Free Clinic: Provides basic needs extractions, fillings and cleanings. Scheduling wait time is 6 months in advanced. Dentists are volunteers.
  - Share Ourselves (SOS): Services unknown
- 2. What is the process for uninsured/undocumented to be seen?
  - Individuals can be referred to/assisted with applying for insurance.
  - Individuals can be referred to dental schools.
  - Individuals can be seen at FQHCs.
- 3. What happens to children of undocumented patients?
- Parents do not want to sign children up for Medi-Cal.

Ivonne shared she will inquire with the Coalition of Community Clinics and will have an update.

## **Review & Update Workgroup Action Plan**

- Schools of Dentistry & Hygiene
  - The group reviewed and updated the list.
  - The finalized list will be uploaded on the website.
- Process to Share Health Fair Info
  - The group agreed that sending an email reminder to members to share upcoming events during the meeting member announcement section is sufficient for sharing health fair information.
  - Other Topics Discussed
    - Sahiti mentioned the upcoming CDA Cares event in San Bernardino is on September 27, 2019 for community.
    - The group reviewed the 211 reports of data; the report shows that 7,232 clicks to request general dentistry.
  - Review of Workgroup Action Plan
    - The group will promote Smile, California and distribute the communications calendar.
    - The Healthy Smiles referral line should be active starting in October.
    - The Pedodontist list will be finalized and shared with group for next meeting.
