### Item I: Call to Order/Welcome

- Mark welcomed the subcommittee and introduced staff and co-chairs
- Briefly discussed the MHSA Plan Update and updated everyone that it would be posted on the MHSA website on Friday, April 8<sup>th</sup>.

### Item II: PEI Update – Mark Lawrenz

- Mark went over how outcomes were presented in the past.
- PEI programs fall within three areas of service: Community Focused Services, School Focused Services, and System Enhancements
- PEI Regulations were finalized in October 2015– Currently in transition of complying with the regulations
- The PEI Regulations- have been a challenge to comply with, but the County is doing everything to try to meet the new reporting requirements.

# Item III: MHSA PEI – 14/15 Outcomes – Camille Basilio

- Camille went over the demographics for participants in PEI programs.
- Discussed program outcomes using measurement tools WHO-5 Well-Being Index, PARA-SE scale, and PHQ-9
- Most programs showed significant improvements in well-being and parenting confidence and decrease in levels of depression

### Item IV: MHSA PEI – Program Successes/Challenges – Mark Lawrenz

- Mark discussed successes with OC Links and Warmline, reporting significant increases on number of calls/online chats received.
- Discussed the success of Community Counseling and Supportive Services Program and the formation of its bilingual counseling team





- School Based Mental Health Services Program now serves middle schools in the Santa Ana Unified School District
- Challenges faced: There are ongoing efforts to recruit and retain bilingual and bicultural staff challenges; working with schools, collecting linkage outcomes, minimum wage increases, child care, evidence-based practices and outcome tools.
- There are plans to standardize outcomes, fully implement PEI Regulations, and quality improvement using outcomes and satisfaction survey data
