Proposed Change(s): OC Waste & Recycling - owner/operator of the Frank R. Bowerman Landfill (Site) - has submitted an application proposing a number of non-major design and operational changes and updates to the Report of Facility Information prepared in a Joint Technical Document (JTD) format. The proposed changes and updates include, but not limited to:

- Addition of perimeter gas migration monitoring probes P-7R and P-8
- Changes in the development of Phase VIIIB
- Incorporation of renewed Waste Discharge Requirements (WDRs)/Monitoring & Reporting Program (M&RP) Order No. R8-2018-011
- Acceptance of non-hazardous Cathode Ray Tube (CRT) panel glass, treated wood waste, non-hazardous contaminated soils, and non-hazardous wastes/waste-diverted materials
- Incorporation of Policy and Procedures (P&P) for acceptance/disposal of dead animals

LEA Determination: The LEA has accepted the application after determining the proposed changes and updates do not conflict with the existing Solid Waste Facility Permit, meet applicable State Minimum Standards, and are consistent with all CEQA documents prepared for the Site.
