#### I. CALL TO ORDER

#### IV. EMS/HEM REPORT

#### • EMS Health Emergency Management Report

- Please continue to go to our website, <u>www.healthdisasteroc.org/ems</u> to view reports, including ambulance offload times and hospital diversion. All trauma centers can receive pediatric trauma patients and this is important because it relates to surge and overwhelming the ER.
- The Orange County Health Care Agency Public Health Officer declared a local health emergency based on ongoing risk and likelihood of Coronavirus positive patients being identified in Orange County. There are no PUI patients under investigations. The AOC is activated at the lowest level to be ready and prepared to respond to the issue.
- Dave Gorlin from OC HART spoke about the new communications group that would provide backup communications when all other systems fail. He will send out a newsletter to the group with his contact information.

#### V. OLD BUSINESS

- 2019/2020 Hospital Advisory Committee Goals Goal #1: Ensure each facility has a COOP or (outline) collaboratively designed by the end of 2019. Activities will be to offer training for foundation fundamental carry forward and have Kaiser and CHOC assist those in how to get started and going in the right direction. The new deadline is at the end of the year 2020 and then reassess. Goal #2: Establish a network with surrounding coalition members. Nicola Harwood will share the City of Orange Network documents, templates and process and even attend your first meeting. Activity for this goal is to have your first meeting by the end of the year. HEM staff needs to be present for the meetings.
- **2019 Hazard Vulnerability Assessment –** Mike De Laby will revise the HVA report. This will remain on the agenda until he gets it corrected.
- Hospital PIO Training There is one workshop left, March 3<sup>rd</sup> and March 4th. The attachment is in the agenda packet if you wish to attend.
- PPE Distribution Distribution will be in March and the schedule will be sent out once it is complete. a
  workgroup was established at the last meeting to discuss the training needs for the new PPE. We are going to
  meet on March 3<sup>rd</sup> to determine what the next steps will be.

- Disaster Assets (Decon/Disaster/MODS Trailers) We have five ambulance disaster trailers, ten decontamination trailers and two mobile oxygen dispensing systems. The tires have been replaced on the trailers. We are currently waiting on a quote from a vendor to bring the decon trailers up to par. The rotation of hospitals has not been planned yet. The MODS trailers are going to be towed to the warehouse from St. Joe's and then we will decide what to do with them.
- **EMS Health EM Recruitment –** We currently have one PH Nurse, two HEM Program Supervisors, one Staff Specialist, and one Office Assistant positions vacant. We also have one staff member out on medical leave.
- Hospital Conex Inventory We are still in the process of trying to reconcile the inventory and do an
  assessment of the MCI cache. MOU inventory needs to be completed by the hospitals and submitted by April
  1, 2020.
- Submission Dates for 2020 If you are seeking funding please make sure your requests include the exact information needed, i.e. lot numbers, vendor names, product numbers, amounts, etc.
- System Policy/Procedures and MOUs We will be renewing MOUs, however we will start adding policies that will ultimately replace MOUs.
- December 2020 Meeting The time for the meeting on December 10, 2020 was changed to 8:30am.

#### VI. NEW BUSINESS

- **Spring Exercise Update –** The spring exercise will be held on June 9<sup>th</sup>. The exercise will be for four hours with a start time of either 5:00am or 12:00pm. The time will be decided at the next planning meeting, which will be on March 9th. If you would like a say, please attend.
- Evaluator Training We will be holding an evaluation training at the AOC.
- **Coalition Surge Test** Stephen Noriega asked for volunteers for the tabletop exercise as we have to evacuate 20% of acute care beds. Chris from CHOC and Ruth from OC Global volunteered.
- Statewide Exercise Planning Donna Mayer asked for volunteers to co-chair the Statewide Exercise planning. Ruth from OC Global and Frank Reyes from Los Alamitos volunteered.

- Roundtable
  - Chris Riccardi There will be a Pediatric Disaster Coalition in January that will be discussing best practices.
  - Calvin Fakkema Calvin asked what the route is to acquire N95 masks. Donna Mayer stated that since there is a nationwide shortage a MAC group has been created. Each hospital that requested masks will be scored according to the MAC group and then given to the hospitals with the most need.

2020-2021 has been a trying time for all of us. Nonetheless, we have witnessed the Orange County Health Care and EMS System work together as a cohesive body to provide vital and necessary services to the constituents of Orange County. To that end, as we continue to absorb valuable lessons and begin to consider demobilization processes including After Action reporting, internal procedures and improvement planning etc., Orange County Emergency Medical Services (OCEMS) will be reviewing our resource request processes and what that might look like for HCCOC moving forward.

Currently if your facility has excess disposable assets previously requested from OCEMS to support COVID-19 activation and response, we encourage you to reach out to your HCCOC partners in order to provide support and share resources. Alternatively, feel free to add the assets to your facilities existing medical/health cache for patient/staff care or for training purposes. OCEMS will not accept any disposable items back in to inventory, e.g. gowns, gloves, goggles, viral testing media, etc. Equipment such as cardiac monitors, County Procured ventilators, Western Shelters, etc. may be housed at your facilities on a case by case basis. However, many of these items will need to be asset tracked by OCEMS per State and Federal guidelines.

We are so very proud of the work that we have accomplished together and equally excited about reviving ongoing HCCOC meetings in the very near future. Our goal is to continue to provide a forum for the Orange County Health Care system to network and exchange ideas, resources and information. Please continue to monitor your emails for eGov.delivery notification regarding meeting schedules.
