





9-1-1 Ambulance Transports appear to have plateaued and are now at normal (pre-pandemic) levels (Updated 8/18/21).




Non-Emergency Ambulance Transports have been trending lower. (Updated 8/18/21).



- Ambulance Patient Offload Time (APOT) is defined as the time the ambulance arrives at the receiving destination (wheels stop) to the time that the ambulance crew physically transfers the patient to the ED gurney. Last 24 hours: Countywide 40m00s since the report creation time (8/18/21 @ 0953).
- Fourteen (14) ERCs had APOT times greater than thirty (30) minutes.
- Three (3) ERCs had APOT times greater than sixty (60) minutes.

The chart below displays a daily trend over the <u>last 30 days</u>.




#### 7 DAY HIS TORY BED OCCUPANCY | 08/17/2021









