James Vanderpool – Oral Re: Reported that City of Buena Park received the Helen Putnam Award for Excellence for the Buena Park Navigation Center in collaboration with 13 north Orange County cities to assist homeless transition to permanent housing

Paul Wyatt – Oral Re: Agreement that pace does need to increase; with more state and federal funding, it is necessary to ensure Orange County gets every dollar it is eligible for; the commission can help with strategy and to outline available funding and identify priorities and recommendations

Sue Parks – Oral Re: Participation in previous Point in Time Count was enlightening; updated commission on United Way's Landlord Incentive Program that has helped over 515 people including 100 that were veterans

Office of Care Coordination Update

State Funding - \$22 billion Housing and Homelessness Package

- \$10 billion for housing programs, which will result in 84,000 new affordable housing units, including 44,000 homeless units
 - Additionally, the budget includes funding for:
 - Expanded rental assistance
 - Foreclosure prevention
 - Mortgage assistance
 - First-time homeowner investments
 - Financing innovative ways to produce and enhance the state's supply of long-term affordable housing.
- The total homelessness budget is \$12 billion, which includes funding for both 2021-22 and 2022-23
 - The package invests in a comprehensive approach to housing and services across the range of homelessness interventions to:
 - Rebuild California's behavioral health housing system
 - Expand access to affordable housing
 - Assist local governments to develop encampment outreach strategies
 - Provide additional resources for Homekey acquisitions

Office of Care Coordination Update

OC Continuum of Care: HMIS Data 4/01/2021 - 6/30/2021

- Households Served 10,375
- Clients Served 18,297
- Active Agencies 48
- Active Projects 218
- Exit Destination to Permanent Housing 2,289 clients (1,038 households)
 - "Permanent Housing" means any permanent destination such as a unit rented by the client, a Permanent Supportive Housing units, or staying with friends/family permanently.


Working Group Ad Hoc Prevention Definition and Goal

Short-term intervention provided to individuals and families at-risk of homelessness or experiencing a housing crisis to achieve housing stability

Goal is to keep people in their homes and avoid an eviction with short term interventions to stabilize housing

Working Group Ad Hoc Best Practice in Prevention

- Emergency Rental Assistance
- Financial Assistance Crisis grants/temporary relief payments, payment of rental arrears, past due utility bills and unexpected expenses
- Landlord mediation and Housing Courts
- Conflict resolution, family reconnection and mediation
- Independent living skills to ensure tenant readiness and budgeting skills
- Job/employment readiness
- Case management/wraparound service navigation after housing placement

Working Group Ad Hoc

Prevention Principles & Commitments

Recommendations to incorporate across our contracting, service development and capacity building

- Early intervention identify risk factors and target those at-risk
- Increase community awareness and education
- Harm reduction and strengths-based approaches
- Effective reentry and transition planning -Prevent returns and address institutionalization
- Measure Outcomes- establish a causal link between the intervention and prevention
- Housing sustainability prevent returns to homelessness and ensure longitudinal success
