Mental Health & Recovery Services (MHRS) Update for June 2022				

## Adult and Older Adult Mental Health & Recovery Services (MHRS)

**Substance Use Disorder: Santa Ana Substance Use Disorder County Clinic** at 401 W. Civic Center Drive Santa Ana now offers Sublocade (the long acting form of Buprenorphine) as one of the Medication Assisted Treatment (MAT) options. **Pacific Educational Services** (PES-ebs) located in 600 West Santa Ana Blvd Santa Ana now also offers Medication Assisted Treatment options.

**Collaborative Services:** The General Population FSPs and Criminal Justice FSP will be able to serve an additional 60 adults living with serious mental illness who need intensive outpatient services. For the Criminal Justice FSP, the program is unable to remain at their current location after 7/1/22 and is actively working to find a new location. The program is coordinating for psychiatric appointments to be provided at one of the existing FSP locations while other services will be provided in the field until a new location can be secured. For the **CalWORKs** program, effective 7/1/22, College Community Services will provide services in the East and West regions while Mariposa Women and Family Center will provide services in the North and South regions.

**Housing and Supportive Services:** On 6/1/22, Jamboree Housing Corporation hosted the **Huntington Beach Seniors Groundbreaking Ceremony**. This housing project has 21 Mental Health Services Act (MHSA) dedicated units, with a total of 43 affordable units. Creating 43 homes for low-income seniors as well as formerly homeless seniors. On 6/2/22, C&C Development celebrated the Grand Opening of the **Altrudy Lane Seniors apartments**, located in the City of Yorba Linda. This housing project is 100% affordable senior development for individuals 62 years of age and older. MHSA provided funding for ten of the 48 units. **Pathways OASIS** will be the lead onsite provider for the MHSA residents.

The new inpatient services medi-cal managed care MA now includes 6 general acute care hospital facilities: UCI Medical Center, Anaheim Global Medical Center, Orange County Global Medical Center, College Hospital Costa Mesa, Huntington Beach Hospital, and Anaheim Community Hospital. Both , the **Long-Term Care Enhanced Residential Treatment** agreement with Anne Sippi, as well as the Psychiatric Skilled Nursing Facility MA include increased funding to contract for additional beds at the 1 Board and Care Facility as well as each of the 6 Institution for Mental Disease (IMD) facilities located throughout Southern California, as there is a need for increased long-term beds within our system of care. Lastly, the BOS also approved the agreement with **Royale**, which also included increased staffing and funding for both locations of this long-term care provider to meet needs and increased acuity of clients being referred to their Therapeutic Residential Center and Mental Health Rehabilitation Center facilities.

## **Children, Youth and Prevention Mental Health and Recovery Services**

The **Office of Suicide Prevention** (OSP) launched the mental health awareness campaign in May with messages from the HCA Director, Chief of MHRS and a Resolution from the BOS promoting the State's new Mental Health Awareness Initiative, "**Take Action for Mental Health**," which is in both English and Spanish (<u>www.TakeAction4MH.com</u>). HCA collaborated with community providers to organize a variety of activities to raise awareness and foster community dialogue. These included school and family-based events, events for Orange County's diverse ethnic communities including Asian, Hispanic, Middle Eastern and North African communities, events for LGBT and TAY youth, veterans and seniors focused events. Activities included workshops, film screenings followed with live discussions, a resource fair with many collaborative partners in attendance, webinars, podcasts, "Open Mic" Night, family fun nights, happy hours, honest hours, yoga and other activities for individuals to participate in. In person events included gardening and art workshops, conferences, photo voice exhibitions, panel discussions, resource fairs, tabling events and outreach.

Additional highlights from May included a live post game concert by Josh Turner at the Angels Baseball Stadium on May 21<sup>st</sup> during an Angel's game to honor OC veterans. Mental health awareness signage including the OC Navigator information was displayed in the stadium and on the Big LED outside the stadium. In addition, the astounding success of Orange County students in the annual statewide Initiative Directing Change Program and Youth Film Contest. A total of 320 young people from 17 schools in OC submitted 118 films about mental health awareness and suicide prevention. ## Mental Health Services Act (MHSA)

The **MHSA Plan Update for FY 2022-23** was continued to the 6/28/22 BOS meeting. A big Thank you to the BHAB for hosting the Public Hearing in May and for their quick turnaround to writing a letter of support for the BOS on the MHSA Plan Update. The MHSA Office will begin hosting informational/planning meetings again in the start of the new fiscal year. The MHSA Office will be putting together a calendar of programs to be shared with the community in the near future. Meetings will be held from 1-2 pm on the  $3^{rd}$  Mondays of each month.
