



SUBJECT: Final Report on the Placentia Transition

Dear Chair Hasselbrink and OCFA Board of Directors:

I am pleased to provide you with the City's final report on its transition from the Orange County Fire Authority to the implementation of the Placentia Fire and Life Safety Department (PFLS) and 911/Advanced Life Support EMS program. As you are aware, at the conclusion of a competitive RFP process, in June 2019 the Placentia City Council voted to start its own fire department and contract with Lynch EMS for paramedic services. In less than one year the City has successfully staffed, equipped and trained a modern fire department, public safety communications center and state-of-the-art emergency medical services (EMS) program. In addition, we have worked collaboratively with the County of Orange and the Local Agency Formation Commission to establish an Out-of-Area Service Agreement to provide fire protection and EMS services to the unincorporated County island located within Placentia known as "Hamer Island." Overall, the transition, implementation and performance of our new fire department, communications center and private EMS service provider have exceeded the City's goals and expectations. Further information and data on the City's fire and EMS operations are noted below.

Regarding emergency communications, the City has implemented a sophisticated and robust emergency medical and fire dispatch protocol system. The emergency medical dispatch component was reviewed and approved by the Orange County Health Care Agency's Medical Director, Dr. Carl Schultz. Our emergency communications center has already begun the process of becoming a nationally accredited dispatch center, which will become the first of its kind within Orange County. Our EMS partners at Lynch are providing high quality service and expertise in 911-Paramedic (EMS). They already have been credited with saving lives in our community and have demonstrated the capacity to provide additional EMS resources into our community or others as needed. Our fire department, which consists of very experienced lateral firefighters has proven its effectiveness on several emergencies including a recent 2-alarm commercial fire.

The data we have collected over the past two months of our initial launch indicates that we have reduced emergency response times in our community by nearly 50% when compared to OCFA the prior year. This can be attributed to using ambulances and

paramedic squad units to respond to medical emergencies instead of a 55,000-pound plus fire apparatus. In addition, the City's investment in emergency vehicle traffic signal preemption devices throughout major intersections has contributed to reducing response times further. Finally, the data clearly indicates that the Placentia fire/EMS service model is resilient and self-sufficient given the substantial reduction in mutual aid from our neighbors. This is due in part to the fact that our fire engines rarely go to the hospital, thus reducing the amount of time those units are out of service.

As an example, the following table provides a year-over-year comparison of mutual aid calls into Placentia. As the data clearly demonstrates, Placentia has required far less mutual aid assistance than OCFA required in 2019 and further illustrates the persistent and excessive aid imbalance between municipal fire departments and OCFA. Our detractors have continually stated that Placentia's service model will require constant assistance from its neighbors; however the opposite is true. The incontrivertable fact is the Placentia Model is resilient and requires far less assistance from our neighbors than OCFA required while serving Placentia.

Despite Placentia's availability to assist its neighbors, the City has confirmed that the surrounding fire departments, including OCFA, have decided to purposely bypass Placentia on aid requests. The attached log shows each instance where the City's units were available to respond to assist residents in neighboring jurisdictions as the closest available unit but were purposely bypassed causing neighboring agencies to drive through Placentia Code-3 enroute to some emergencies, in some cases several miles further. These actions by OCFA and others serve to not only lengthen emergency response times into surrounding communities to the detriment of the public we serve, but creates significant liability issues for those agencies, including Yorba Linda.

When discussing Placentia's ability to serve its own residents as well as assist its neighbors, its important to take this comparison into consideration: On June 17, 2020, two weeks before the final transition, OCFA responded to a 2-alarm fire on La Jolla Street. A total of 33 units from 5 agencies responded to this incident to assist OCFA. On September 16, 2020, the Placentia Fire and Life Safety Department responded to a 2-alarm fire and a total of 17 units from 5 agencies responded to assist. If the OCFA with its 1,200 employees and nearly half-billion-dollar annual budget requires this much assistance, then how could anyone begrudge the City of Placentia, with its 140 employees and \$40 million annual budget, for asking for the same assistance? The truth of the matter is, in the modern fire service all fire agencies require assistance regardless of the size of the agency or what equipment they own. The purpose is to simply respond with the closest available unit to ensure the public's safety.

From a financial perspective, when the City planned to establish our fire department and new EMS program we anticipated a \$1.7 million savings within the first year alone. When compared to OCFA's cost for FY 2020-21, I'm happy to report the City is now budgeted to save \$2.3 million in our first year of operation. Additionally, based upon a comparison of OCFA's historical costs when compared to the City's historical costs, Placentia anticipates saving \$27 million over the next 10 years.

As demonstrated above, the Placentia Model has proven to be very effective at serving our community. I along with my colleagues on the City Council and City staff take great pride in this fact as well as the financial savings for our taxpayers. We are confident in the abilities of our public safety providers and as always we stand ready to assist our neighbors should they desire to enter into a mutually beneficial aid agreement or call upon us.
