#### Behavioral Health Services (BHS) Director's Report - Jeff Nagel

Dr. Nagel took questions in reference to the Behavioral Health Services (BHS) update memo that was sent out to the board via email. He highlighted a few additional items, including the collaborative courts had a total of 17 Drug Court graduations and 28 DUI Court Graduations during the month of July. The Crisis Residential programs continue to be fully operational and we are now requiring to provide Covid testing before entering the program. Moreover, OASIS has been delivering Care Packages with coping tools for their vulnerable population. Furthermore, MHSSA Grant has been approved by the Board, and it will fund 7 regional coordinators as well as training and education efforts to increase access to services for school aged kids. This is slated to start in September. Sacramento County is piloting putting mental health counselors in the schools, we have started conversations with CalOptima to see how we can provide these services to Orange County Schools. In addition, Dr. Nagel highlighted the partnership with Angel's Baseball in advertising the Stigma Free OC campaign as well as know the Signs.

#### **BHS Director's Report – Continued**

Finally, BHS continues to look at reduction in expenditures to take appropriate actions in ensuring we will have a fund balance at the end of FY 22/23.

### ADEPT Update- Carolyn Secrist

Carolyn highlighted some of the prevention services taking place, there are two prescription drug opioid media campaigns. The first campaign is targeting the youth ages 11-18, designed to educate the youth that not all prescription drugs are safe. It will focus mainly targeting social media and will launch mid-September. The second campaign is targeting adults, it launched back in February and will relaunch in the fall, Wrongforyou.com. We are continuing our school based efforts into a virtual mode using curriculum that have shown to decrease substance use, services will be offered for elementary through high school aged kids. We will use "Too good for Drugs", "Project Alert", "Life Skills", and "The All Stars". Furthermore, the next National Take Back day is set to take place on October 24<sup>th</sup>, we will provide a list of the all drop sites soon.

#### New Business:

- Suicide Prevention and Recovery Happens Resolution: Courtney Smith and Nita Tewari worked with Natalie and Tyler from Supervisor Steel's office, in which they agreed to help in writing a resolution for Suicide Prevention month.
- Dr. Rose informed the board that the new Data Notebook will be out soon, we have been advised by the CALBHB/C that they will be releasing this soon. More details to come.
- Matthew provided some information regarding the Integrated Services Plan by the Sherriff's department, and expressed concern for the Musick Facility Plans for the recovery piece of it stating the community in opposition to some of the details in the plan. He expressed an interest in interfacing with the law enforcement collaborative. Dr. Nagel reached out to the Correctional Health partners, suggested using stakeholders in their planning process similar to BHS.
- Frederick Williams reminded everyone that September is National Recovery month.
