- [CBS Los Angeles, 2/11/21](#): The Federal Emergency Management Agency (FEMA) will give the State of California \$823 million to open more than 100 community vaccination sites that will be selected by the State.

- [WebMD, 2/16/21](#): The World Health Organization authorized the AstraZeneca-University of Oxford COVID-19 vaccine on Monday, which will allow the United Nations to distribute doses to low- and middle-income countries.

VACCINE FACTS & TIPS



TRUTH: Vaccines are not being given to children and adolescents because they have not yet been tested with that age, not because they have been found to be dangerous to children and adolescents.

FACT: It typically takes a few weeks for the body to build immunity (protection against the virus that causes COVID-19) after vaccination. That means it's possible a person could be infected with the virus that causes COVID-19 just before or just after vaccination and still get sick. [Learn more.](#)

TIP: If you are receiving your vaccination at a County of Orange Super POD, you will need to bring your photo ID with proof of Orange County residency or Orange County employment, and documentation of an appointment through Othena. Those who cannot demonstrate eligibility as a senior 65 or over, or as a healthcare worker, will be turned away.


