BHS Director's Report – Mary Hale

- Mary updated the board on Behavioral Health Services county and contract programs. In Adult and Older Adult Behavioral Health Services (AOABHS) our Goodwill program will have a graduation with 47 participants on November 6, 2014. Also, this program has settled into their new location, 2250 S. Yale Street, Suite A, Santa Ana, CA 92704. We currently have about 620 people in our Shelter Plus Care Program. The next orientation for this program will be October 16, 2014. Further, we have two new housing projects in progress. Cotton's Pointe Grand Opening will be on October 15, 2014. There are 23 Mental Health Service Act (MHSA) funded units at this property. It should be noted that this housing received the Senior Affordable Housing Project of the Year Award. Finally, Cerritos Family Apartments will be opening in November and has committed 19 MHSA funded units.
- In regards to Children, Youth, and Prevention Behavioral Health Services (CYPBHS), a prescription drug campaign has been contracted with the Community Services Programs (CSP) to focus on the accessibility and misconception of prescription and opiate drug use among adolescents and young adults. This campaign will benefit the entire county, however will target 10 cities: San Clemente, Hunting Beach, Mission Viejo, Orange, Yorba Linda, Fullerton, Santa Ana, Costa Mesa, Newport Beach and Tustin. The campaign will run from December 2014 through June 2015. Moreover in Prevention and Intervention, a Request for Proposal (RFP) has been released for the planning and implementation of a Needs Assessment to determine the community's current training needs, targeting the representatives of the PEI priority populations, their family members, and those working with this population.
