The Orange County Request for Proposals (RFP) for 9-1-1 Emergency Ambulance Transportation Services #OC2014-01 has concluded with the Board of Supervisor's action on April 28, 2015 to award contracts within five county administered ambulance regions.

On June 1, 2015 Care Ambulance Services, Inc. and Emergency Ambulance Service, Inc. will be providing regional ambulance service under County contract. Orange County Emergency Medical Services (OCEMS) and the Orange County Fire Authority (OCFA) continue to adjust operations to assure a seamless transition and uniform provision of ambulance services.
