Call to Order at 9:05 a.m. by Richard McConaughy.

Welcome and Introductions

- Each member and attendee introduced themselves and their respective affiliation.

Behavioral Health Services (BHS) Director's Report – Jenny Qian

- Jenny updated the board on BHS county and contract services. In Adult and Older Adult Behavioral Health (AOABH), the Peer Mentoring contract for services will go to the Board of Supervisors (BOS) in September as will the South and West Wellness Center.
- In Children, Youth and Prevention Behavioral Health Services, particularly Innovations, services have begun for two Round 2 Innovations projects: 1) Behavioral Health Services for Military Families and 2) Religious Leaders Behavioral Health Training Services. In our Prevention and Intervention Division, OC Links received a total of 10,134 calls and chats in Fiscal Year 2014-2015 accounting for an average of 844 calls/chats monthly in the second year of operation. This is an average 39% increase in monthly calls from the previous years. Also, the Community Counseling and Supportive Services have received 67 referrals with 50 individuals being screened for services so far and currently 23 enrolled in services. Finally, the School Based Mental Health Services placed clinicians in the Santa Ana Unified School District beginning the week of June 29, 2015 and is providing services to middle school students. 250 referrals have been received so far and staff is in the process of screening and enrolling students.
