**PC-1210 PROGRAMS  
TRACK I and II**

Track I fees for completing the PC1210 program are noted below. Fee includes provider Assessment Fee, \$78 County Enrollment Fee, as well as six (6) required random substance abuse tests over a four-month period.

Participants entering Track II must remain with the Track I provider who administered services. Fees vary for Track II, so participants should consult with the provider about Track II fees, prior to enrolling in the program in Track I. Transferring between providers is limited to Track II and only for extreme situations. In most instances, there will be a charge by both the discharging and receiving provider, as well as other conditions that must be met before a transfer may be approved.
