This issue of the Our+Care newsletter is about the Orange County HIV Planning Council (Council) and its committees. The Council and its committees make important decisions for people living with HIV in Orange County. The Council and its committees are always looking for new members who want to get involved. If you are interested in participating, go to a meeting to check it out! This newsletter is to provide information on what each committee does. Keep reading to find out more!

## What is the Council?

The Council is made up of different members from the HIV community. Their role is to make sure that HIV funding is spent on needed services in the county. These needed services help people living with HIV disease (PLWHD) achieve viral suppression and live healthy lives. **The Council meets on the 2<sup>nd</sup> Wednesday of the month at 6:00pm.** 

# How does the Council make decisions?

The Council has many committees that focus on different Council tasks. Each committee works on items that get presented to the Council for approval. In addition, there are committees that develop items and make recommendations but are not official committees of the Council (See back page for more information).



# What are the Council committees and what do they do? The following are committees

of the Council. Interested individuals are always welcomed to attend as guests.

### **HIV Client Advocacy Committee**

(HCAC) is made up of consumers of HIV services and provides feedback on Council items from a consumer point of view. This committee develops the biannual Our+Care newsletter, contributes client surveys and focus groups, and recommends service priorities for Council consideration. Members of this committee advocate for and recruit PLWHD to participate on Council issues. Typically, this is the first committee that consumers join to become more involved with the Council process.

HCAC meets on the 3<sup>rd</sup> Monday of the month at 6:00pm.

#### Prevention and Care Strategies Committee (PCSC) is responsible

for creating a plan for HIV prevention and care services in Orange County. This committee identifies ways to improve outcomes along the HIV Care Continuum.

PCSC meets on the 4<sup>th</sup> Tuesday of the month at 2:30pm.



## Priority Setting, Allocations, and

**Planning (PSAP)** is responsible reviewing data, available resources, and current and emerging needs to provide prioritization and funding allocation recommendations to the Council.

PSAP meets on the 4<sup>th</sup> Wednesday of the month at 6:00pm.

**Membership and Training** is responsible for planning trainings for members and ensuring that the Council is made up of members that mirror the Orange County HIV epidemic. They are also responsible for assisting in recruiting members on the Council and its committees. Membership and Training meets on the 3<sup>rd</sup> Wednesday of the month at 6:00pm.

**Executive Committee** reviews all items from committees before the items are presented to Council for approval. This committee is also responsible for the Evaluation of the Administrative Mechanism to ensure funds are being disbursed in a timely manner and to the areas of greatest need. **Executive Committee meets on the 1<sup>st</sup> Wednesday of the month at 6:00pm.** 

#### **Other Committees**

The following are not committees of the Council. However, they make recommendations for the Council's consideration.

#### Quality Management (QM) Committee reviews and

develops quality improvement indicators to measure HIV health outcomes for Ryan White services. This committee develops standards of care for which must be approved by the Council.

QM Committee meets on the 1<sup>st</sup> Monday of the month at 6:00pm.

Housing Committee discusses housing issues and housing options related to PLWHD in Orange County. The committee provides recommendations regarding housing priorities to the Council.

The Housing Committee meets quarterly on the 1<sup>st</sup> Monday of the month at 3:00pm.
