Dear Ms. McConnell:

On behalf of Providence St. Joseph Health, which in Orange County includes Mission Hospital Laguna Beach, Mission Hospital Mission Viejo, St. Joseph Hospital Orange, St. Jude Medical Center, and Hoag Memorial Presbyterian, I would like to provide comments to the OC Health Care Agency's report, "The Orange County Trauma System: 2018." We find that the OC Health Agency report serves as an initial basis for dialogue about the current trauma system within Orange County. However, we find it important to note that some data reported in the agency report may be inaccurate (based on our understanding of what was provided.)

This includes, but is not limited to:

- Trauma transport times may be flawed (some geographies such as Newport Beach are excluded in drive-time analysis; inconsistencies with independent known data; future 405 Freeway widening project transit delays not addressed);
- Missing data for <u>all</u> trauma victims (including those at non-trauma centers); and
- Inconsistent data sets (the date range of some data inquiries are inconsistent or outdated. See "Institutional Volume and Acuity Numbers for Trauma Centers").

Therefore, PSJH believes the county should conduct a comprehensive analysis of the Orange County Trauma System to resolve these perceived data inconsistencies to further ensure the county assess any potential vulnerabilities for providing adequate trauma care to the county's 3.2 million residents (and growing) for the foreseeable future.

Some additional considerations for finding significant need to assess Orange County's trauma system are the following:

- While population growth is *relatively* slow (per the agency report), 10 percent growth in only 10 years represents a significant increase to trauma volume, which would require time to adapt.
- The American College of Surgeons recommends one trauma center per 300,000 people.
- San Diego County has a similar size population (est. 3 million), which accommodates five trauma centers to Orange County's three. LA County has 15 trauma centers for their approximately 10 million residents.

- The OC Health Care Agency report does not appear to include data for Newport Beach, where travel times may be comparable to Huntington Beach the longest travel times in the Orange County ranging from 20-22 minutes.
- It is important to have an objective and comprehensive analysis of where an additional trauma center should be located (taking into account these additional factors)
 - o Geography, population, trauma visits by zip code, travel time
