Orange County Emergency Medical Services (OCEMS) in collaboration with the American Heart Association (AHA), California American College of Emergency Physicians (Cal ACEP), and the EMS Medical Director's Association of California (EMDAC) coordinates the annual Sidewalk CPR event where the goal is to train as many members of the public as possible in hands only Cardiopulmonary Resuscitation (CPR). Every year through Sidewalk CPR, Southern California trains tens of thousands of community members in hands only CPR in hopes that these lifesaving basics may be the key to someone's survival.

OCEMS would like to invite your agency to participate in this year's Sidewalk CPR event. The event will be held throughout the week of June 3rd through June 9th 2018. If you are interested in participating please fill out the attached "2018 SideWalk CPR Registration Form." OCEMS will provide your agency with a "tool kit" containing resources such as event flyer templates, SideWalkCPR fact sheets, sign-in sheets, and hand outs.

OCEMS will coordinate press releases for SideWalk CPR but encourage each agency to publicize the date, hours of operation, and location for their training to the local community. The instructors providing the training to the public does not have to have a CPR instructor card but will need to be comfortable and knowledgeable in performing CPR. Every agency will report the number of citizens trained during the event to the EMS agency. OCEMS will report the total number trained in Orange County to the AHA, and any interested parties.
