#### **Approval of Minutes – Action Item**

- February 28, 2018
  - Sandra Finestone made a motion to approve the minutes from the February 28, 2016 meeting and Matthew Holzmann seconded the motion with no corrections. The minutes were approved for the record. Vote: 6 yes/1 no

### Behavioral Health Services (BHS) Director's Report – Jeff Nagel

Jeff Nagel took questions in reference to the BHS update memo that was sent out to the board ahead of time. Matt suggested advising the Board of Supervisors (BOS) in being supportive a site in Irvine located by the old Marine Base for additional housing for the homeless. Jeff informed the MHB that on March 19<sup>th</sup> the BOS directed HCA to bring back proposals to spend \$70.5 million of CCS funds towards Housing. There is an April 17<sup>th</sup> Board meeting where HCA will bring proposals to the BOS; if there should be any proposals from the MHB please forward those to Jeff Nagel. BHS is working diligently in getting a plan in place for the BOS.

Michaell inquired about the In-Reach Program, if inmates would be getting released with medication on hand. Jeff clarified that this program will have significant impact on the jail population in being linked with services upon being released, there is no clarification on medication but it will be looked into. Jeff added that the Proposition 47 Grant will provide a 24/7 Community Support Resource Center to link inmates upon release to resources. This proposal will be going to the BOS for their approval on April 24<sup>th</sup>.

#### **Public Comment**

• Steve McNally-

Mr. McNally focused his comment on the MHSA Annual Plan Update, referencing page 223 on the budgets. He showed concern for MHSA budget and allocated funds and urged the MHB look at the numbers being provided better planning going forward.

Michael Arnot-

Mr. Arnot shared his concerns with the MHSA budget and urged the MHB members to stay active in being involved with the planning of MHSA funds as well as asking the Finance and Resource Ad Hoc Committee to take a deeper dive into any budgeting issues with unallocated MHSA dollars.

#### **Presentation**

CalOptima Member Health Needs Assessment and Intergovernmental Transfer Grant Request for Proposals By: Claudia Hernandez, MSLM, Manager, Strategic Development

Claudia Hernandez presented a comprehensive presentation on the CalOptima Member Health Needs Assessment. She provided an overview of the report and provided information on barriers to care, lack of awareness, and negative impacts. Furthermore, she provided the list of Request for Proposals available for the \$14.1million available in IGT 5 funds.

#### **Committee Reports**

- MHSA Steering Committee: Matt Holzmann reported that at their last meeting there
  was a presentation on Community Events and School Services and there was
  discussion on providing a clear definition on MHSA housing.
- Older Adult Services: Karyl Dupee reported that the committee meets monthly and has been focusing on classifying services provided for Older Adults while also identifying gaps and barriers. Their goal is to narrow it down to 2-3 main barriers to then write a report to the BOS.
- CALBHBC: Alisa Chatprapachai reported that the California Association of Local Behavioral Health Boards and Commissions is moving forward with the letter of support for the peer specialist bill.
- Community Quality CQIC: Joy reported that the committee reviewed reports on budgets and assessments of programs.
- Community Action Advisory Committee: Joy reported that there have been concerns with lack of staffing on a MHSA funded program, NAMI Warm line. In addition, she expressed for a need to have a presentation on MHSA funding so that they can be proactive in planning for further allocations.
