- □ Partner Updates
 - Claudia shared that Cal Optima is working on managed care carve of dental. Cal Optima has only done

□ Emergency Dental Services

- Group suggested a list of numbers would be provided for referrals. Also, include underutilized clinics (such as Assistance League) for referrals as there is usually a long period of a wait list.
- Group expressed emphasis of education of oral care and importance of baby teeth. This topic also connected to the Education & Public Awareness and Access & Utilization of Dental Services Workgroups.

Local Oral Health Program

- Evaluation/Data Update (See Page 3- Attachment A)
 Sahiti provided an overview of the California and Orange County Smile Survey.
 - She informed that a smile survey of 3rd grade students is being implemented in California.
 Orange County is conducting a Smile Survey on Kindergarteners and 3rd graders. The Center for Oral Health (COH) has been subcontracted to implement in Orange and other counties.
 - Sahiti informed that COH is attempting to acquire low and high income representation. Sahiti
 stated that OCDE have been presented to twice and are all in. She shared that all south
 county schools did not select to participate in survey. La Habra was included in survey and
 very interested to be included in Orange County data. COH expects to have Smile Survey
 completed by June.
 - Group suggested to attend conference in August and use school readiness nurses. Also, suggested possible incentives such as dental hygiene kit and gift cards to teachers who participate in survey. However, will have to confer with school.

Overview of California and Orange County Smile Survey For Oral Health Collaborative Review 3/25/19

Background:

The Smile Survey, methodologically known as the Basic Screening Survey (BSS), is a public health surveillance tool utilized to assess the oral health status of populations. The 'survey' entails a non-invasive and observational open-mouth assessment. The methodology was developed by the Association of State and Territorial Dental Directors and is implemented by dental public health programs across the U.S. BSS methodologies have been developed for Kindergarten and 3rd Grade students, and older adults.

California and Orange County Smile Survey:

Currently, a smile survey of 3rd grade students is being implemented in California by California Department of Public Health's Office of Oral Health. California State University of Sacramento has been contracted to implement this survey and the Center for Oral Health has been subcontracted to implement it in Alameda, Orange, Riverside, Sacramento and San Bernardino counties. The CA Smile Survey will not provide county-level estimates of disease prevalence.

To obtain county-level estimates of disease prevalence, a smile survey is also being implemented in Orange County by Health Care Agency's Local Oral Health Program. The Center for Oral Health was contracted to implement this survey. The Local Oral Health Programs, in their work plan from the Office of Oral Health, are required to also support the implementation of the CA smile survey in their respective counties.

Sampling:

A probabilistic sample (random stratified sample proportional to size) of public schools with 10 or more 3rd grade students has been selected. The sample is stratified by select variables (see table below) to ensure appropriate representation of the population.
