# SHELTER SYSTEM RESPONSE

# Cold Weather Shelter Programs

- Transitioned both Fullerton and Santa Ana Armories to new alternative locations
- Shifted to 24/7 operations
- Santa Ana alternative location will remain operational until Yale Transitional Center opens

# County Operated Shelters

- Provided handwashing stations and recommendations on necessary sanitation practices
- Contracted a meal provider for the Courtyard Transitional Center to shift from volunteers and donations
- Provided isolation areas on site for those who may be exhibiting symptoms
- Opened Joplin as an alternative shelter site for the South Service Planning Area

# Technical Assistance

- Office of Care Coordination and Public Health provided technical assistance to homeless service providers across the county
- Distributed PPE to homeless service providers
- Conducted sites visits and provided recommendations to modify programs to implement social distancing guidelines and preventative measures



# CONTINUUM OF CARE RESPONSE

# State Funding

- State provided \$100 million directly to local governments to protect the health and safety of those experiencing homelessness
- Orange County Continuum of Care received \$1,336,888 in funding

# **Local Priorities**

- Provide alternative shelter for individuals and families at high risk for severe COVID-19 illness due to age or underlying health conditions
- Provide alternative shelter for individuals and families sick or symptomatic for COVID-19
- Provide shelter to unsheltered families

# **Outcomes**

- Served 53 unsheltered families 182 persons total
- Served 145 individual households at high-risk for severe COVID-19 illness
- 10 homeless service providers have accessed this funding

# PROJECT ROOMKEY OVERVIEW

### **Background**

 Project Roomkey is a State initiative designed to prevent and mitigate the spread of COVID-19 by providing noncongregate shelter in hotels and motels for sick and medically vulnerable persons experiencing homelessness

### **Temporary Isolation Shelter**

- Provides temporary quarantine or isolation for those experiencing homelessness who are sick or symptomatic for COVID-19
- Operator performs ongoing health assessments to determine progress and recovery
- Upon recovery, the individual will be discharged back to the referring community or an appropriate shelter location

# Vulnerable Populations Temporary Shelter

- Individuals who are medically vulnerable and/or age 65 and older
- Individuals must be asymptomatic for COVID-19
- Actively performs assessments for COVID-19 symptoms
- If an individual becomes symptomatic, they will be relocated to a temporary isolation shelter



# PROJECT ROOMKEY OPERATIONS

- The operator provides daily meals and snacks, medical oversight, transportation, supportive services and coordinates with the Health Care Agency for behavioral health services.
- The Office of Care Coordination established a Project Roomkey hotline to provide information, determine eligibility and refer into the program
- Shelter operators were asked to keep beds available for individuals they referred into Project Roomkey



# PROJECT HOMEKEY OVERVIEW

- Project Homekey is the next phase in the State's response to serve people experiencing homelessness or at risk of homelessness and whom are also at risk of serious illness from COVID-19.
- It provides an opportunity to purchase and rehabilitate buildings to convert them into interim or permanent, long-term housing.

### **Funding Available**

- \$645 million in funding available across the state
- The state is divided into eight regions for funding allocations; Orange County is in the Southern California Region (without LA) along with Imperial, Riverside, San Bernardino and Ventura Counties.
- The Southern California Region was allocated:
  - \$55,577,540 in Federal Coronavirus Relief Funds
  - \$5,052,504 in State General Funds



# PROJECT HOMEKEY PROCESS

# **Eligible Applicants**

- Eligible applicants may apply independently or jointly with a for-profit or nonprofit corporation.
- Eligible applicants include:
  - Cities
  - Counties
  - Other local public entities, housing authorities or federally recognized tribal governments



### **Timeline**

- July 10, 2020 County released a Request for Information to identify potential projects
- July 16, 2020 State released the Notice of Funding Availability
- August 13, 2020 Deadline for submittal of priority applications
- August 2020 Awards to be announced on a rolling basis
- September 29, 2020 Final application due date

# **Application**

- Project 1
  - 60 units
  - \$13.4 million for acquisition, rehabilitation and operating costs
- Project 2
  - 20 units
  - \$2 million for acquisition
- Project 3
  - 72 units
  - \$12.7 million for acquisition, rehabilitation and operating costs
