IV. OCEMS REPORT

• OCEMS Report: David Johnson reported the Health Care Agency Operation Center continues its Level 2 activation. A poll situation status report continues to be to be done to determine hospital status and to determine how each facility handles heavy patient loads. Hospitals continue to see a lot of psychiatric patients which take considerable resources and time. Hospitals are handling surges and diversion in a better manner. Regional hospital staff issues continue to occur throughout the US.

Danielle Ogaz reported that the State EMS Authority has approved the extension for the local optional scope of practice for paramedics and emergency medical technicians to perform vaccinations and COVID testing and the skills verification requirements. Both extensions have been granted through December 31, 2021.

Health Emergency Management Report: Dr. Grewal reported that COVID numbers continue to improve. He reported that while there may be a surge of COVID patients, it appears that this surge consists of pediatric patients who are not vaccinated.

Orange County Hospital Diversion Report: David Johnson reported on hospital diversion trends seen in the months of July and August 2021. Mr. Johnson reported since July, hospital diversion hours have plateaued with the upcoming flu season coming out. Further diversion information may be viewed on the MHOAC dashboard posted to the OCEMS website.

• Ambulance Patient Off-Load Times (APOT): Attached to the agenda are the APOT reports released since the last meeting. Laurent Repass reported that the month of August indicates that it was the busiest month of transports on record since 2016. APOT times have been increasing while diversion is trending downward. Due to a calculation data error noted for the period of January 1 to July 31, 2021, the monthly reports have been revised and they are posted to the OCEMS website.

COVID LOSPs Sunset September 30, 2021

Prior to the July, 2021 meeting, it was the intent of the State EMS Authority to sunset all local Optional Scope of Practices granted by the EMS Authority. Through September 30, 2021 (see above information under the EMS report). This has been changed to December 31, 2021.
