



FDA Approves Moderna COVID-19 Vaccine

On January 31, the U.S. Food and Drug Administration (FDA) issued approval of the Moderna vaccine for the prevention of COVID-19 in individuals age 18 and older. The vaccine will be marketed as Spikevax and was previously available under emergency use authorization.

The Pfizer vaccine was previously approved by the FDA for individuals age 16 and older and is being marketed as Comirnaty for the same population. The vaccine remains emergency use authorized for children and youth ages 5-15.

What Do I Do If I Tested Positive on a COVID-19 Antigen Test?

Rapid COVID-19 antigen self-tests allow individuals to conveniently learn their COVID-19 status. These are different than home collection kits such as those available through the OC Health Care Agency in which specimens are collected at home, but then are sent to a laboratory for processing.



There is no requirement to report positive results from self-administered tests not performed under laboratory or healthcare professional oversight; however, anyone who tests positive is required to isolate according to the County Health Order and CDC guidelines.

FDA Issues Alert on Unauthorized Rapid Tests

The FDA recently issued an alert warning people to stop using the Empowered Diagnostics CovClear COVID-19 Rapid Antigen Test and ImmunoPass COVID-19 Neutralizing Antibody Rapid Test.
