- COVID-19 positivity cases are increasing, and hospitalizations are up
- There is no update on influenza
- 6 cases of Monkeypox in California
- Hospital diversion is an issue and trending up--66 hours for diversion yesterday
- APOT is also elevated and increasing
- The AOC is still activated, supporting logistics for Mobile POD vaccinations; the process is winding down
- We have over-the counter COVID test kits available. This allocation is specifically for underserved populations, specifically those who have poor access to testing (e.g., the uninsured/under-insured) and those in high risk settings (e.g., congregate living)
- Professional use test kits available for testing of employees and patients. Need a CLIA Certificate of Waiver to use
 - Only need to report positive tests.
- May 20th is the deadline for the grant cycle.
- We are conducting training classes at the Environmental Health building. The training calendar has been sent out.
