Mental Health Services Act (MHSA) Community Program Planning Overview

Michelle Smith provided a comprehensive overview of the MHSA Community Program Planning (CPP). She included information on what is the CPP and how it is utilized to determine how to best serve communities through the programs contained in the development of the MHSA Three-Year pram and Expenditure Plan and Annual Updates. Michelle explained the statue and process, to include the BHAB involvement during the MHSA Public Hearing hosted by the BHAB where the BHAB will review and approve that the CPP took place. In addition, she provided a detailed overview of the stakeholder process framework and what is required. Furthermore, she provided the members with a BHAB timeline for MHSA related items.

Matthew Holzmann reminded the members of the BHAB retreat on December 14th. Karla Perez informed the BHAB that they can now register as volunteers, and she would help with that process. This is to be able to claim reimbursement on mileage and per diems while they attend events.

• put an action plan to DHCS that would help enhance the mobile crisis units, to include CAT and Outreach and Engagement team. This grant will include the vehicles, technology, software and hardware. In addition, it will add training and marketing for the crisis services.

Committee Reports

- Older Adults Committee: In 2021 the OA committee came up with a pilot project targeting wraparound services for those who are homeless or at risk of homelessness, have a mental illness and have developed a neurocognitive condition such as dementia. While it's a great idea, there are a lot of roadblocks with current County funding streams, however, Michelle suggested to introduce this as an Innovation project. This idea will be shared during the MHSA Summit on November 10th.
- Finance Committee- Chase reported they met and disused their mission and priorities and will be putting together a draft that will be reviewed soon.
