Item 1. Call to Order: John Paquette called the meeting to order at 6:04 pm.

Item 2. Welcome and Introductions:

John Paquette welcomed all in attendance. John provided an overview of the agenda, the purpose of public comment, and how the meeting will be facilitated. The meeting was held in office and also as a webinar due to special circumstances. A roll call for attendance was taken. A quorum was established.

Item 3. Approval of Agenda:

Adelmo Chan put forward a motion to approve the agenda. The Chair repeated the motion. Dr. Huffman seconded the motion. There was no discussion or public comment. The motion passed by consensus.

Item 4. Approval of September 14, 2022 Minutes:

Adelmo Chan put forward a motion to approve the September 14, 2022 minutes. The Chair repeated the motion. Dr. Ried seconded the motion. There was no discussion or public comment. The motion passed by consensus.

Item 5. Public Comment:

Ignacio Alvarez informed members that October 15th was National Latinx AIDS Awareness Day.

Item 6. Our Working Council Discussion:

There were no comment cards for review. John Paquette reminded members that comment cards can be submitted to Planning Council Support via email.

Item 7. Approval of National HIV/AIDS Strategy (NHAS) Goals:

Matilde Gonzalez-Flores provided an overview of the National HIV/AIDS Strategy (NHAS) proposed goals and objectives for 2025 for Orange County. The members reviewed the proposed goals and made the following change:

Goal 1: Prevent New HIV Infections

- Objective 1.3
 - Progress Indicator The goal was decreased from 65% to 50% based on trends in available data.

Dr. Gupta put forward a motion to approve the NHAS 2025 goals with the change. The Chair repeated the motion. Adelmo Chan seconded the motion. There was no discussion or public comment. The Chair asked for the members in favor say yay. The Chair then asked for any nay votes. The yay votes were unanimous and the motion carried to approve the NHAS 2025 goals with the change.

Item 8. Review Q1 Expenditure Report:

Mindy He provided an overview of the Q1 Expenditure Report. The report covered the first quarter, March 1, 2022 to May 31, 2022.

Item 9. Approval of FY 2023-24 Level Funding Scenario Allocations:

Mindy He provided an overview of the FY 2023-24 Level Funding Scenario Allocations. The proposed Level Funding Scenario reflect the FY22 Ryan White Part A and MAI allocations based on award approved by Council on July 13, 2022 as follows:

- Outpatient Ambulatory Care: \$1,293,470
- Medical Retention Services: \$637,374
- Linkage to Care: \$274,365
- Health Insurance Premium: \$65,750
- Mental Health: \$39,851
- Early Intervention Services: \$173,778
- Medical Nutrition Therapy: \$136,031
- Food Bank Core: \$41,650
- Home Delivered Meals: \$32,976
- Nutritional Supplements: \$70,275
- Home Health/Para-Professional Care: \$294,237
- Client Support Services: \$337,728
- Client Advocacy: \$253,637
- Eligibility Screening: \$352,261
- EFA Medications: \$11,000
- Short-Term Supportive Housing: \$378,151
- Medical Transportation Services: \$232,391
- Outreach Services: \$18,665
- Food Bank Support: \$97,905
- Other Professional Services including Legal Services: \$88,445

Minority AIDS Initiative (MAI) :

- Medical Retention Services: \$347,510
- Linkage to Care: \$84,543

The Chair repeated the motion. Dr. Ried seconded the motion. There was no discussion or public comment. The Chair asked for the members in favor say yay. The Chair then asked for any nay votes. The yay votes were unanimous and the motion carried to approve the FY 2023-24 Level Funding Scenario Allocations.

Item 10. Approval of FY 2023-24 Decrease Funding and Staging Scenario Allocations::

Mindy He provided an overview of the FY 2023-24 Decrease Funding and Staging Scenario Allocations. On September 28, 2022 the PSAP Committee approved the decrease funding scenario and recommended staging in the following order:

Part A

- 1. Early Intervention Services: Proposed decrease of \$5,000 to \$168,778
- 2. Client Support Services: Proposed decrease of \$20,000 to \$317,728
- 3. Eligibility Screening: Proposed decrease of \$20,000 to \$332,261
- 4. Mental Health Services: Proposed decrease of \$8,000 to \$31,851
- 5. Food Bank: Proposed decrease of \$51,405 to \$46,500

Minority AIDS Initiative (MAI)

There are no proposed decreases for MAI in the Decrease Funding Scenario.

Adelmo Chan put forward a motion to approve the FY 2023-24 Decrease Funding and Staging Scenario Allocations. The Chair repeated the motion. Dr. Gupta seconded the motion. The yay votes were unanimous and the motion carried to approve the FY 2023-24 Decrease Funding Scenario Allocations.
