- The September 8 and December 8, 2021 meeting minutes were approved

### III. EMS/HEM REPORT

- COVID-19 positivity case rates and hospitalizations are down
- SNF/LTC outbreaks are down to 7 SNF and 2 LTC
- The new BA2 variant of Omicron has not been causing much of a problem; however, it's more infectious than the BA1 variant and so far, represents approx. 16% of cases nationwide
- The AOC is still activated, supporting logistics for Mobile POD vaccinations; the process is winding down
- We also have over the counter iHealth test kits available. This allocation was specifically for healthcare workers to return to work after being isolated for COVID-19; per the direction of the State, we can distribute and give a supply for your workers. Please reach out to us
- BinaxNOW kits are only available for Outpatient clinics and SNF/LTCs; some test kits received without enough testing solution, but if you contact Abbott Industries, they will send you replacement testing solution
- We are filling two positions to help us on various projects, exercises, and drills; we will have people to support the operation
- Eddie Morales is doing inventory on disaster connex containers at the hospitals. Hospitals are a hub in a disaster; supporting them to make sure we have adequate supplies geographically dispersed in the county
- Training opportunities are coming up and will be free, virtually or in person. We have finalized an agreement with facilitator Hal Kempfer, a subject matter expert in disaster & emergency preparedness. We are working on a training calendar, and once it's complete, we will share it with the coalition members
- We verified the currently contact list for Hospice Home Health reaching out to facilities that not coalition members, and they did not know there was an HCCOC.
