• The September 9 and December 9, 2021 minutes were approved.

IV. EMS/HEM REPORT

- COVID positivity case rates are declining (14 cases per 100k); hospitalizations are also down.
- There is pressure on the hospitals' systems in terms of patient load and getting ambulances to offload patients, but slowly improving
- The main variant is the BA5 for COVID
- New variant is the BA.4.6 is starting to grow
- Bivalent booster that covers BA4 and BA5 are now available
- Monkeypox case rates are increasing; 170 cases in OC most cases are in LA and San Francisco
- The AOC has a surplus of PPE, and we must reduce inventory in our warehouse. If you need gowns and face masks; reach out to us.
- We have BinaxNOW professional use test kits. If interested, reach out to us through our resource request process.
- We have over the counter tests; we prioritize those for disadvantaged populations and people who don't have access to testing; please reach out to request them.
- HEM has three new team members: Chad Cossey, Chris Schuldes, and Justin Newton. Chad brings expertise and experience specific to the healthcare coalition and HPP. We are planning drills and exercises.
- We are starting a 5-year grant cycle through CDPH and waiting for funding.
- We need to increase participation and engagement. Interact with your peers and encourage them to sign up with the coalition.
- Dr. Grewal asked about the dialysate supply shortage, and Michael Trazi advised that it was mainly a transportation issue that had been resolved.
