Presentation: The Changing Face of New Fatherhood – Daniel Singley, Ph.D., ABPP, PMH-C

- Dr. Daniel Singley: clinical psychologist in San Diego with an emphasis on men's issues and masculinity; clinical work, research, presentations and trainings
- Presentation on fatherhood, mood disorders, and changing the face of new fatherhood
 - Fathers in contact with infants experience dysregulation of any hormonal concentration
 - Research shows gender differences overlap
 - 1 in 10 dads have depression; 2-18 % have anxiety
- Need to provide support and get your own support; need to normalize both parents and need to provide support and get support

Orange County Perinatal Council Meeting Highlights January 10, 2023

- Recommended resources: Postpartum Supports International (PSI) Hotline (1-800-944-4773) will connect to local person
- Dad involvement = better emotional and behavioral regulation
- Maternal postpartum depression (PPD) is the strongest predictor of paternal PPD
- Father engagement and overlap
- Needs
 - Few statistics available
 - Support for fathers is lower than support for moms
 - Birth trauma is on the rise
 - Support post-partum PTSD

Prenatal care providers, public defender's office, have big overarching goals, for this group. Developing protocols required by State but not put in place by partners. Hoping to formalize soon.

- Capacity: 10 nurses/250 clients
- Current Caseload: 98 clients; Current availability: 152 clients
- 32 referrals received October December 2022; plenty of availability and looking for referrals
- Specific to first-time parents; need to enroll prior to 28th week pregnancy
- CNSD has a centralized referral system and intake:
