Ending the HIV Epidemic (EHE) Initiative

In 2019, the U.S. government announced the Ending the HIV Epidemic (EHE) Initiative. The EHE Initiative aims to lower the number of new HIV diagnoses in the U.S. by 90% by 2030. There are four (4) key EHE strategies:



Diagnose HIV as early as possible



Treat HIV quickly and effectively



Prevent the spread of HIV



Respond quickly to HIV outbreaks

The EHE Initiative focuses on areas in the U.S. where the number of HIV cases is high, like in Orange County. The main goals of the EHE Initiative are to:

- Increase funding and fill gaps in services not offered through the Ryan White HIV/AIDS Program (Ryan White)
- Create new programs to provide more services for HIV testing, prevention, treatment, and care
- Use data to find where HIV cases are increasing to plan for new activities

In Orange County, EHE Initiative services are helping to:

- Increase the number of people who know their HIV status
- Increase access to HIV prevention services like pre-exposure prophylaxis (PrEP)
- Help more people living with HIV (PLWH) stay in HIV medical care
- Connect people newly diagnosed to care faster
- Improve the health of all PLWH, especially among priority populations that have more cases of HIV

In Orange County, priority populations are:

- Men who have Sex with Men (MSM) of color (African American/Black or Hispanic/Latinx);
- Individuals with history of incarceration;
- Individuals with history of substance use, including people who inject drugs;
- Other priority populations including young people (19-25), transgender individuals, and PrEP eligible individuals.

EHE SERVICES IN ORANGE COUNTY

The Centers for Disease Control and Prevention (CDC) and Health Resources and Services Administration (HRSA) provide funding to Orange County for EHE services. The Orange County Health Care Agency (OCHCA) worked with community members, PLWH, and HIV service providers to create an EHE Plan to meet the goals of the EHE Initiative.

EHE treatment and care services in Orange County are available to those who are HIV positive. A client may also need to meet other service qualifications depending on

the EHE service. Some of the main differences between the EHE Program and Ryan White in Orange County are:

- To be eligible for Ryan White you must be HIV positive, low-income, and live in Orange County
- Ryan White clients must be screened for eligibility every year. The EHE Program does not require re-screening.
- Only services allowed under the Ryan White program can be provided. The EHE Program does not limit services to only Ryan White services.

EHE SERVICES IN ORANGE COUNTY (CONTINUED)

EHE services in Orange County that are part of Orange County's EHE Plan include:

PrEP (pre-exposure prophylaxis) Navigation	PrEP is medicine that reduces the chances of getting HIV from sex or injection drug use. Rapid Antiretroviral Therapy (ART)	Provides HIV medicine as soon as possible and usually on the same day to people newly diagnosed with HIV or who are not currently taking HIV medicine.	TTC Clinic	For information, call the TTC Clinic at (714) 834-7991.
HIV Care	For PLWH who are not virally suppressed, do not qualify for Ryan White medical care, and who have barriers to stay in HIV medical care.	TTC Clinic	For information, call the TTC Clinic at (714) 834-7991.
