I. CALL TO ORDER

The meeting was called to order by Peter Anderson, MD at 9:04 a.m.

II. INTRODUCTIONS/ANNOUNCEMENTS by Carl Schultz, MD

III. APPROVAL OF MINUTES

Minutes from the September 12, 2023, meeting was approved as submitted.

IV. OCEMS REPORT

OCEMS Report by Carl Schultz, MD

Policy 645 was updated and sent out for public comment. There were no comments returned so it is now an official policy, and it is posted on the website.

Epi Report by Kristen Karpow

COVID numbers are decreasing due to the number of tests people are taking. Overall, we are showing that hospitalizations are still low. We are moving into influenza season, but we are at low levels in California and it's the same for RSV.

On the Health Disaster Preparedness side, Chad Cossey mentioned the Statewide Health and Medical Exercise will take place on Thursday. Hospitals and ambulance companies will be participating. Patients will be simulated through ReddiNet.

CCERC are creating respiratory guidelines, education and management.

The Stroke CQI initial meeting was in October. The next meeting is in January. We will present some cases then. The next Orange County Stroke Society Meeting is November 30th at the Fire Authority.

Trauma Centers had a couple of pediatric meetings regarding pediatric trauma distribution, and we will be revisiting that quarterly to see how that works. Trauma program managers are busy with reverifications with the new standards with the gray book.

Ambulance Patient Off-Load Time (APOT) and Diversion Report by Laurent Repass

APOT times are still essentially flat. They were at 31 minutes and 59 seconds for August and 31 minutes and 58 seconds for September. Transport volume has also been essentially flat, right around 16,000 per month or about 500 per day. We are still working on the October numbers. I do have a preliminary for APOT: 33 minutes and 32 seconds and 16,175 transports. Not a very big increase for October.

Diversions – we like to see the ED diversion threshold at 6%. The countywide diversion for August was 7.7% but we were right at 6% for September.

Bi-Directional Data Exchange Project by Laurent Repass

UCI went live in June. Kaiser went live on November 2nd. Prime Health is going live on November 28th and the four Providence hospitals are going live on December 6th. All in all, this project has to be completed by the end of June. We are hopeful every hospital is able to meet that deadline.

NEMSIS 3.5 by Laurent Repass

The new version of Nemsis will be 3.5 by January 2024. 88% of EMS providers have implemented their plans at this time. 95% should be by November 15th. We should be 100% complete by the end of the year. December 18th is the deadline and if they miss the date their license could be in jeopardy.

VI. **NEW BUSINESS**

La Palma Intercommunity Hospital Redesignation as an ERC by Genise Silva, RN

La Palma had a site visit and found three deficiencies:

- 1. Response on ReddiNet as far as MCIs, (real and drills), polls, daily HAVbed and patient census. We are asking for a Corrective Action Plan to be sent within the next 60 days.
- 2. APOT Times We'd like to see a Corrective Action Plan to be sent within the next sixty days to decrease this number. We are not expecting that number to go down in sixty days, just that they are working on it and they are providing us a plan on how they are going to start to decrease that and level out their APOT with their diversion.
- 3. EMTALA Adherence we would like them to provide all of their emergency department staff, including their registration and MDs with further education on EMTALA, including

giving us the curriculum they are providing. We are expecting this to be done within the next 90 days.

We also had a couple of recommendations that are not contingent on their designation but would like to have some action:

- 1. They are 100% on their H.E.A.R., which we acknowledge and would like to continue that.
- 2. Building a working relationship with their specialty centers to get more clinical education and collaboration.
- 3. Develop a policy regarding a facility's possession of a Chempak and provide education to staff regarding usage and deployment to outside facilities.

We are asking for an endorsement of three years conditional on these three deficiencies, so we will need a motion for that. Motion was approved.

We also visited Mission Hospital for their five designations, everything minus trauma. You can expect to see their facility designation summary at the January FAC meeting.
