**LEA Findings per Title 27, § 21665(c) and § 21665(d):** The Local Enforcement Agency (LEA) finds that the proposed changes are consistent with all CEQA documents; is acceptable and consistent with all state minimum standards; and the proposed changes do not conflict with the existing solid waste facility permit (SWFP).

**Description of Proposed Changes:** The Transfer Processing Report (TPR) was amended to reflect minor changes (i.e., change in verbiage, removal of equipment, update appendices, etc.). In addition, the LEA is modifying the SWFP to update/change the landowner information and include SB1383 sampling data in the self-monitoring report submittal.
