# **Program Highlights**

### **Adult & Older Adult Services (AOA)**:

- Intensive Outpatient Full Service Partnership & PACT: Three clients from TAO Central FSP successfully graduated from mental health diversion and had their charges dropped.
- Housing & Supportive Services:
  - Pelican Harbor, a Huntington Beach Senior Housing facility, and Wise Place apartments started move ins for MHSA units.
  - The Groundbreaking Ceremony for Lincoln Avenue Apartments took place on February 18, 2025. This project will include 55 units of affordable housing, 13 of which are funded by the Mental Health Services Act (MHSA).
- OC4Vets: The contracts with US Vets, Working Wardrobes, and Child Guidance Center are ending June 30, 2025.

## **BHS Navigation**

- Jail to Community Reentry Program (JCRP) took the initiative in coordinating the connection
  of the Long Term Care and Correction Health Services Medical Director to ensure they could
  discuss the required documents that would be needed for Public Guardian's office conserves
  in gathering and completing referrals for clients.
- OC Outreach & Engagement (OC O&E) North & Central SPA had the first biweekly collaborative meeting with Healthcare in Action, CalOptima's street medicine provider in Anaheim and Garden Grove, setting the tone for what a collaborative working relationship between Healthcare in Action and OC O&E would look like.
- Prop 36 became effective in December 2024. JCRP and BHS Substance Use Disorder created a workflow to assist with conducting American Society of Addiction Medicine evaluations for individuals to be assessed while incarcerated in Orange County jails. As of February 21, 2025, JCRP began receiving these PROP 36 ASAM requests and has begun completing the assessments.
- OC O&E's South SPA submitted three Care Court petitions in the month of February.

### BHS/MHSA Program Planning and Administration Program

- Innovation:
  - O PIVOT INN Project: The INN Staff have begun internal planning meetings to set up the structure of the project, including component staffing patterns and roles, identifying project managers and champions, and finalizing negotiations with an evaluation vendor. Staff was also invited to present project status updates at the Behavioral Health Advisory Board Older Adult Committee and will begin attending regularly to support PIVOT component activities.
  - Psychiatric Advance Directives: INN Staff launched the initial pilot of the PADs digital platform on February 24, 2025. The INN Staff hosted a successful kickoff meeting for Peer Support Specialists and Service Chiefs from the PACT, AOT and CARE program to announce the launch and address any questions. INN Staff will host ongoing monthly implementation meetings to gather staff feedback, address challenges and resolve potential barriers to successful implementation.

- Office of Wellness and Suicide Prevention:
  - The Office of Wellness and Suicide Prevention (OWSP) had another active month, participating in a variety of events throughout the County, engaging more than 300 individuals and families in activities that promoted and supported discussion around mental health issues, suicide prevention and mental health resources available in Orange County. Additionally, OWSP team member, Jennifer Que, facilitated the Hope Card Project with The Boys and Girls Club of Irvine and the Wellness Center South.



On January 15, 2025, the Office of Suicide Prevention welcomed over 40 community members at this quarter's CSPC meeting, held in partnership with Access California Services. HCA's Behavioral Health Services Training Services Administrator Teresa Renteria presented on workplaces wellness, its crucial role in suicide prevention, and our BHS Workplace Wellness Advocate program. Attendees participated in an interactive goal-setting activity in support of our suicide prevention plan for OC. These goals include increasing awareness about suicide prevention, increasing connectedness between communities, increasing detection, providing crisis care, connecting suicide loss survivors to support, and reducing access to lethal means. Organizations and members also shared updates about program services and upcoming community events.



## Children & Youth Services (CYS)

- Western Youth Services Anaheim clinic began conducting Incredible Years Parenting Groups in Spanish with childcare offered to families.
- Waymakers Guidance Center launched a new group therapy program in January called Skills for Life, which uses the five core Dialectical Behavioral Therapy modules of mindfulness, distress tolerance, emotion regulation, interpersonal effectiveness, and dialectics. Participants will learn simple and effective techniques to help them feel more in control of their emotions and in turn improve their overall mental well-being.

#### Crisis and Acute Care (CAC):

- On February 5, 2025, the new Mobile Crisis Unit note went live in the Electronic Health Records. The buildout of the new Mobile Crisis Unit progress notes took extensive collaboration between the Crisis Assessment Team (CAT) leadership, IRIS Liaison Team and IT to develop.
- On February 7, 2025, CAT began piloting providing transportation for adult clients experiencing a mental health crisis to Crisis Stabilization receiving facilities using retrofitted County vehicles.

#### Forensics:

- Clinical Stepdown Committee: The clinical stepdown committee will meet monthly to discuss
  cases that are ready to stepdown from LPS 60 days prior to their annual re-hearing. These
  will be cases that Public Guardian's office identifies as not suitable for recertification of LPS.
  The committee will be made up of representatives from Public Guardian, LPS Forensic
  Psychology, AOT, CARE, FSP's. The purpose is to create a nexus and close the gap when
  stepping down from LPS; and to increase appropriate referrals to the appropriate programs.
  Case conferences will begin January 1, 2025
- CARE FSP Dismissed Client Outreach: CARE FSP to provide outreach, engagement and support to dismissed CARE clients. To effectively outreach dismissed clients from the Care Act program, CARE FSP will focus on different client categories and collecting relevant data. By following this workflow and collecting comprehensive data, CARE FSP can effectively manage outreach efforts for dismissed clients, enhancing engagement and program success.

### Substance Use Disorder (SUD):

Prop 36 now has 12 individuals who have plead into the program as of February 21, 2025.
 Most of the individuals being evaluated continue to be unhoused Medi-Cal beneficiaries, who are being referred to residential treatment. The Prop 36 program continues to refine processes to facilitate the evaluation process.

#### CAC:

# **Highlights of the Month**

- AOA- Outpatient: Anaheim Outpatient Clinic received positive feedback from two clients about the clubhouse and the groups. Last month they had 286 visitors, with 42 new attendees.
  - Client 1: "I think that the clubhouse is a great place to visit. I also think that the groups are awesome. The staff are very courteous and willing to help"
  - Client 2: "I would like to share how wonderful it is to know the 'Clubhouse' is here because it changes my whole day. It's a safe place to talk, do crafts, or go to group. It is very homey."
- BHS Navigation: A client had identified his concern that due to his struggles of being homeless, he had barriers to reporting to probation officers and the mental health program upon his release. The client shared that he was trying to survive upon release and that reporting to probation did not become a priority as he could not get there. JCRP identified his extensive history of homelessness. A JCRP clinician and OC O&E staff collaborated on a plan to ensure the client's release would be successful by assisting the client in connecting with his probation officer and his treatment program. With extensive collaboration, JCRP provided a warm handoff of the client to OC O&E at the jail lobby on the day of release. OC O&E took the client to probation and a contracted FSP, where he was later housed.

- BHS Navigation: OC O&E team responded in collaboration with OC Sherriff Department for a male client who had experienced unsheltered homelessness for several years, was nearly blind, and was well-known by the Midway City Police Department and Huntington Beach Police Department. This participant expressed that he was ready to get help and didn't want to spend the rest of his life on the streets. In February 2025, he was matched to a housing opportunity and OC O&E assisted this participant in moving into his own apartment in Huntington Beach. He shared that he could see a car wash from his apartment balcony, where he used to sleep for years. He thanked our team for being part of his journey.
- CYS: Children and Youth Services West had their first Parent Child Interaction Therapy (PCIT) graduation. After many challenges this family faced in the beginning of treatment, they successfully completed PCIT with the support of two PCIT clinicians working tirelessly to make this happen. This family demonstrated courage, dedication, discipline and flexibility throughout the entire process. Both caregiver and child have developed and maintained skills that will make a positive impact for the rest of their life.
- MHSA: NAMI served a parent participant who enrolled in the FSS program in search of hope and help with moving forward after a traumatic instance with their daughter. Their daughter was diagnosed as paranoid schizophrenia and had stabbed her mother in a state of psychosis a few months prior. NAMI spent weeks talking on the phone with the family, listening and thoughtfully asking questions about their experience. Through this, NAMI was able to identify a support system and resources for the family. By NAMI's second month, the staff was able to create a detailed self-care plan, focusing on setting and maintaining boundaries as a part of self-care. Recently, the participant expressed their appreciation to NAMI staff. While they initially were unsure that they would be able to find hope again after experiencing a traumatic event with their daughter, having someone with a non-judgmental attitude to talk to regularly to help process their situation was a huge stepping stone for their healing journey.
- SUD: One of our county-operated SUD programs received a phone call from a grateful
  parent of a client who entered treatment in September. Client had been a victim of sex
  trafficking and was specifically placed in a treatment program with a focus on trauma. The
  client successfully completed the program and is currently residing in a recovery residence
  while attending a community college to pursue a trade to become an aesthetician.
