- Health Disaster Preparedness Report Justin Newton and Chad Cossey
 - o The AOC will be moving to Irvine approximately April 14th.
 - We participated in conjunction with the USPS in a BDS exercise.
 - o There will be a NDMS exercise with Camp Pendleton in which we will participate in.
 - The Statewide Medical and Health Exercise will take place on April 24th from 8am 12pm being a loss of water scenario.
 - The mid-term planning meeting will be on March 18th.
- Ambulance Patient Off-Load Time Jason Azuma

January was our worst month ever with over 18,000 911 transports and increased diversion hours of over 4000 hours. February was published yesterday and is available online. It looks like we are out of the seasonal surge now.

V. UNFINISHED BUSINESS

- The addition of Toradol as a pain medication for use in the prehospital arena is approved. Changes have been made to 325, the mandatory pharmaceutical cache that paramedics carry. The procedure for administering Toradol (PR-75) will be included in the update that comes out next week.
- The Triage Alternate Destination project procedure is missing the formal request by the CSU. Dr. Schultz has to receive and approve the application. The application should be ready by April 1st.

• Impending Updates – There is a draft letter of new policies and revisions of policies and procedures as language was changed or accidentally omitted. These changes will not go out for the 50-day comment period and will be coming out in the next couple of days.
