COMMUNITY PARTNER SPOTLIGHT

June is Pride Month! During Pride Month various events, observances, and celebrations are held to commemorate the contributions and influence the Lesbian, Gay, Bisexual, Transgender, Queer, and Intersex (LGBTQIA+) communities have impacted the world. Pride is a positive stance against discrimination, social stigma, violence and injustice. During Pride we celebrate sexual diversity and gender variance, allyship, justice, equity, and help build community. Celebrating Pride Month also provides an opportunity to raise awareness of the current issues these communities are facing while reaffirming commitments to do more to support the LGBTQI+ communities.

HIV AWARENESS

June 5 is HIV Long-Term Survivors
Awareness Day (HLTSAD). Long term survivors include people who have had HIV for 10 years or more, adults who acquired the virus as babies, and people who were diagnosed before the availability of antiretroviral therapy (ART) in 1996.

Due to the decades of successful HIV research and the advancement of many new treatments, people with HIV are living longer lives and are aging with HIV. This day not only recognizes and honors long-term survivors, but we also observe HLTSAD to raise awareness of the needs, issues, and the journey long term survivors have endured and continue to face.

June 27 is National HIV Testing Day (NHTD)

This day is meant to encourage people to get tested for HIV and raises awareness of treatment and prevention options. Knowing their status empowers people to prioritize their sexual health, choose options to keep themselves and others healthy, and ultimately helps prevent the spread of HIV. There are many places to get an HIV test, find one near you at <u>AIDSVu</u> or for self-testing visit <u>TakeMeHome</u>.

> Mpox

OA is committed to providing updated information related to mpox. HEALTH ACCESS FOR ALL

Strategy 1: Redesigned Care Delivery

OA continues to implement its **Building Healthy Online Communities (BHOC)** self-testing
program to allow for rapid OraQuick test orders
in all jurisdictions in California. The program,

<u>TakeMeHome</u>, is advertised on gay dating apps,
where users see an ad for home testing and are
offered a free HIV-home test kit.


In April, 321 individuals in 37 counties ordered self-test kits, with 211 (65.7%) individuals ordering 2 tests. Additionally, OA's existing TakeMeHome Program continues in the six California Consortium Phase I Ending the HIV Epidemic in America counties. Between the program's initiation in September 1, 2020, and April 30,

2025, 17,140 tests have been distributed. This month, mail-in lab tests (including dried blood spot tests for syphilis, and Hepatitis C, as well as 3-site tests for gonorrhea and chlamydia) accounted for 65 (16.6%) of the 391 total tests distributed in EHE counties. Of those ordering rapid tests, 257 (78.8%) ordered 2 tests.

Since September 2020, 1,904 test kit recipients have completed the anonymous follow up survey from EHE counties; there have been 809 responses from the California expansion since January 2023.

Strategy 3: Fewer Hurdles to Healthcare Coverage

As of May 31, 2025, there are 286 PrEP-AP enrollment sites and 231 clinical provider sites that currently make up the <u>PrEP-AP Provider</u> network.
