



BHSA Full-Service Partnership (FSP) Workgroup Kick-Off Meeting

MEETING SUMMARY

1. Introductions

- Each attendee shared their name and affiliation/organization with the group.
- By show of hands, approximately ¼ or less of workgroup members work solely with youth when asked by Community FSP Co-Chair.

2. Review of Category Slide Deck

- Systems of care will be reviewed to work on leveraging opportunities and identifying gaps in services to meet Prop 1 requirements.
- Waiting for State to identify fidelity tool for County to use for monitoring.

3. Orientation One-Pager for Workgroup Members

- Document will be sent via email to workgroup members by HCA Liaison.

4. Meeting Frequency

- Unable to determine cadence of days/times during meeting. More frequent meetings are necessary through at least December 2025 to assist the County with this stage of planning. Reassessment of meeting frequency will be done further out.
- Meetings will take place twice a month: once in-person and once virtually. HCA Liaison will send out a Doodle poll once possibilities with Co-Chairs and locations can be concluded as final options.

5. Timeline and Goals of the Workgroup

- Workgroup will share recommendations with County. FSP Workgroup Co-Chairs will attend July PAC with to share updates and gather information pertinent to BHSA and FSP Workgroup.
- Workgroup will identify gaps that remain resulting from sunset of MHSA/modernization of BHSA funding and what is available with CalOptima and fee for service, for example.



- Workgroup will strive to work with the understanding that there is a lot that is unknown and still being worked out at the State level. When more guidance is provided by the State, the more it can inform efforts towards workgroup goals.

6. Systems Maps

- The Systems Maps were not covered due to time restraints but will be discussed at the next workgroup meeting.
- A request was made from a workgroup member to see if it is possible to indicate funding source on the maps.
- Another suggestion from a workgroup member was to add grant funded sources on the maps.
- A Funding/Gaps Analysis for FY 25/26 is currently being worked on by HCA.
