
## **STAFF HIGHLIGHT**

OA would like to welcome **Patrick Christensen!**Patrick is the new Chief of the Local Capacity
Building & Program Development Unit in the
Prevention Branch.

Patrick comes to us with a wealth of experience and knowledge from the Complaints Section of the Licensing and Certification Division, within the Department of Health Care Services (DHCS). ## COMMUNITY PARTNER SPOTLIGHT



#### **Dear Ending the Syndemic Partners,**

Thank you for helping to make this year's Ending the Syndemic Symposium a success! The Ending the Syndemic Symposium was co-sponsored by the California Department of Public Health (CDPH), OA and the California Planning Group (CPG). This year's Symposium focused on the themes of Stigma Free Services, Economic Justice and Housing First: three of the social determinants of health on which our work in California is organized. Over the three-day Symposium, speakers addressed these themes and led participants to reflect on how they might implement work to center the health of the priority populations in our Ending the Epidemics: Integrated Statewide Strategic Plan and Ending the Epidemics: Implementation Blueprint.

This Symposium was free and was open to any partner working to end the syndemic of HIV, STIs and HCV in California. Simultaneous Spanish translation was available at all sessions.

The event website will be live through December 2025 to access the conference recordings and materials. Both English and Spanish versions will be available.

CDPH/OA is also in the process of building a permanent website to house all of the recordings and materials from both this year's and last year's Symposiums.

## HIV AWARENESS

National Latinx HIV/AIDS Awareness Day (NLAAD) is observed on October 15 to raise awareness about the disproportionate impact of HIV/AIDS on the Latine community. Social determinants of health to include systemic racism, discrimination, HIV stigma and limited access to quality healthcare.

According to CDPH/OA Surveillance Data, in 2023, the Latine community accounted for 42% of living HIV cases and 57% of new HIV diagnoses. NLAAD promotes HIV testing, prevention and treatment, and education in the Latine community.


### HEALTH ACCESS FOR ALL

### **▶** Strategy 1: Redesigned Care Delivery

OA continues to implement its **Building Healthy Online Communities (BHOC)** self-testing
program to allow for rapid OraQuick test orders
in all jurisdictions in California. The program,


<u>TakeMeHome</u>, is advertised on gay dating apps,
where users see an ad for home testing and are
offered a free HIV-home test kit.

In August, 316 individuals in 36 counties ordered self-test kits, with 213 (67.4%) individuals ordering 2 tests. Additionally, OA's existing TakeMeHome Program continues in the six California Consortium Phase I Ending the HIV



Epidemic in America counties. Between the program's initiation in September 1, 2020, and August 31, 2025, 18,930 tests have been distributed. This month, mail-in lab tests (including dried blood spot tests for syphilis, and Hepatitis C, as well as 3-site tests for gonorrhea and chlamydia) accounted for 188 (37.2%) of the 506 total tests distributed in EHE counties. Of those ordering rapid tests, 240 (75.5%) ordered 2 tests.

Since September 2020, 2,064 test kit recipients have completed the anonymous follow up survey from EHE counties; there have been 905 responses from the California expansion since January 2023.

#### Strategy 3: Fewer Hurdles to Healthcare Coverage

As of September 30, 2025, there are 294 PrEP-AP enrollment sites and 232 clinical provider sites that currently make up the <a href="Prep-AP">Prep-AP</a>
Provider network.
